- 1. Dolly Hannon Clinic-Contract with Dolly has been signed. Confirmed with Liz Snoblen that her facility will be the location for the clinic to be held May 4-5, 2024. Need to start marketing the clinic. Auditor Fee? Discussion held related to cost of hosting this clinic. Mary Linton sent out an estimate of the cost to WDAMI hold this clinic in June including estimated airfare, housing, food etc. total estimated cost was \$3,600.00 for the two-day clinic. Rider's cost would be \$150.00 per 45-minute session. (Hopefully we would have 9 rides per day, total 18 rides). Stall fees would be \$25.00 per day. Auditors would be charged \$25.00 per day. Liz will provide food for a cost of approximately \$300.00. We would need about \$1,000.00 from the WDAMi educational fund to help defray the costs.
